**DIRECT ENERGY REGULATED SERVICES  
GENERAL CONDITIONS OF THE RATE SCHEDULES**

**1. Approval by the Rural Electrification Association**

All REA Rates and Riders of Direct Energy Regulated Services are subject to approval of the Board of Directors of the Rural Electrification Association.

**2. Terms and Conditions of Service**

Service under Direct Energy Regulated Services' Rates and Riders for REA Customers are subject to Direct Energy Regulated Services' Terms and Conditions of REA Regulated Rate Service, as approved by the Board of Directors of the Rural Electrification Association.

**3. Other WSP or Rural Electrification Association Charges**

In addition to the WSP and Rural Electrification Association charges specifically identified in these Rate Schedules, Direct Energy Regulated Services' Rate Classes E5(REA) and E7(REA) will include, as applicable, all ATCO Electric Ltd. charges under Riders A-1, E, and J, as well as any Power Factor Corrections and Price Options, or other Charges or Riders levied by ATCO Electric Ltd. and approved by the Alberta Energy and Utilities Board or any charges levied by a WSP or Rural Electrification Association and approved by its Board of Directors.
